 - Who: Boundless Gowanda; Reality Check; Church youth Groups; Student Activities Councils; Students Against Destructive Decisions; 4H Club
 - What: What do we want to know from teens?
 - Goal topics are marijuana and alcohol
 - Youth goal is to develop youth leadership
 - Coalition agrees that any conversation to get the youth involved will help
 - Choose from the actively involved to pursue youth leadership development
 - How: Looking into options other than zoom to host the “Youth Online Chat”
 - When: Possibly hosting first chat in January
 - It was discussed that depending on initiatives, there may be a need to target communities/districts differently based on their needs and interests

- Tara is looking into applying for this which would allow the coalition to store and edit documents using G-Suites as well as have additional chat and meeting features
